Welcome to Westonia

Westonia came into existence with the discovery of gold in the area in 1910. Initially the area was known as *Weston's Reward* and later as *Westons*.

The *town* of Westonia was named after Alfred David Weston, a sandalwood cutter who prospected in his spare time, and discovered gold near Boodalin Soak in 1910. He pegged the lease and started mining, creating a rush of gold prospectors to the area. A month after Alfred Weston made his initial application for four gold mining leases, Edmund Annear of Burracoppin made an application for a mining lease three miles southeast of Weston's leases at the Boodalin Soak. Annear named the lease the Edna May after an aunt. This lease would eventually become Westonia's Edna May Gold mine, a mine that has been an active gold mine many times since the initial lease was pegged. The Edna May is currently operated by Ramelius Resources.

By 1915 there were two major mines in the area, and the population was in excess of 500, by 1917 the area, by then known as *Westonia*, had a population of more than 2,000. In 1919, low gold prices forced the closure of the mines, and many people left the area.

Westonia was gazetted as a town in February 1926.

By the 1930's the district had also been extensively developed for agriculture and wheat/sheep farming now represents the primary industry in the area. Westonia has however always benefitted greatly from the coexistence of both the mining and agricultural industries within the shire.

Today walking through Westonia is a leap back in time. Established during the gold rush era, the town has restored and rebuilt its fine buildings to create a streetscape straight out of the pioneering era. From the original bank, cafe and greengrocer store to the bright red doors on Westonia's fire station, wander through town and imagine life here during the mining boom of the early 1900s.



Event Overview

The Course

Westonia's Golf Club established in 1973

Then owned by local farmers Pip and Elsie Della Bosca.

Elsie had a great love for sports and saw potential in an unusable piece of farmland to become a golf course. Pip & Elsie approached a golf course designer who pegged out



the course, Pip then got to work clearing the land for the first 9 holes. A community meeting was held to find out if Westonia would like to create a Golf Club. In 1973 the Westonia Golf Club was established. With the hard work and dedication of surrounding farming families, Westonia Golf Course became a full 18-hole Course by 1976. Ross Della Bosca (son of Pip & Elsie) gifted the land to the Shire of Westonia in 2021.

Rules & Eligibility

The annual LGIS Local Government Inter-Municipal Golf Tournament is open to all Shires, Towns and Cities to enter a team/s of up 4 players.

Sponsors and contractors are encouraged to enter a team. Their scores will be entered into the Sponsors section of the day and a Sponsors winner announced. Sponsors and contractors are not considered eligible players for Shires, Towns or Cities unless they fit the eligible player definition.

- The tournament is to be played under the Stableford scoring system
- Teams are to be comprised of at least 3 eligible players to enable a score to be valid.
- Only scores from eligible players will count in the final score for a team
- The team with the highest net score from eligible players will be deemed the tournament winner
- The tournament winner has the rights to host the following year's tournament but cannot win hosting rights two years in a row.
- In the case where a Shire, Town or City wins for a consecutive year, hosting rights will be given to the Shire, Town or City who secures second place.
- Golflink handicaps apply to all eligible players, failure to disclose an official Golflink handicap where one is held with result in immediate disqualification.
- Where a player does not have an official Golflink handicap the maximum allowable handicap will be 18 for men and 25 for women
- Registered teams that do not meet the definition of an eligible player will be ineligible to win the event.
- The definition of an eligible player is:
 - o An amateur golfer (no affiliation with PGA Australia);
 - An employee, CEO or Elected Member of the Shire, Town or City they are representing;
 - A former employee or Elected Member of the Shire, Town or City they are representing; or

A former CEO, President, Mayor or Freeman is eligible to play for any Shire, Town or City.
